### **Old Business:**

A. <a href="Project Update:">Project Update:</a> Nick Loomis gave a project update. We had another bathroom drain issue. This time Lonnie thinks it is really a issue that can be addressed with a change in water flow. Lonnie will be ordering and installing new toilet assemblies that will provide for more water than our current water saver models. We are hopeful that this will help with the issue going forward. We will also be adding seat covers dispensers to each restroom. RAM Builders will be on site on Thursday to install the siding on the north side of the building. There is a little water damage in the corner of Nick's office that will be repaired once the siding has been installed. The damage is from the raining coming through the brink wall. The installation of the siding will address that problem. No action was taken.

Treasurer Foote provided support for the motion. The stipend will be issued in gift cards. Additional discussed included a new, larger donor plaque for the community room. Director Bissonnette shared with the board her plan for future retirement and updated them on discussions regarding a co-director partnership with Asst. Director Loomis. No action was taken.
