To whom it may concern,

On Saturday February 8th Abell Pest Control performed a thermal heat treatment for the Harrison District Library for the elimination of bed bugs. We arrived on sight at 7:00am and instructed HDL staff to remove items from the library that were a hazard or could be damaged by the heat treatment. We started our treatment with a perimeter spray with a residual pesticide that is heat stable. We then set up and had the heat equipment turned on by 9:30am. Due to the size of the library, we zone heated in 2 stages. The first zone which included the offices, bookshelves, and computer area. This first zone was at killing temperature at 4:00pm. No cold spots were detected at that time. Infested materials were removed from the plastic bags and were placed so that they could be thoroughly heated. We held this first zone at temperature until 7:30pm, at which time we moved the equipment into the 2nd zone and began heating. The 2nd zone heated much quicker due to there not being the mass of material that needed to be brought up to temperature like books. The 2nd zone was at temperature at 9:00pm. We then held temperature and turned the heat off at around 12:00am Sunday February 9th. I then performed an inspection of the infested material and locations and found that there was no live activity present at the time of inspection. We then packed our equipment and left the property at 1:30am Sunday February 9th.
